Purpose of the Policy:

The purpose of the Climate Change Mitigation Policy is to "prevent the effects of climate change and develop and maintain efforts to reduce greenhouse gas (GHG) emissions." This falls within the scope of our

environmental responsibilities.

Greenhouse Gas (GHG):

Greenhouse gases include compounds with various heat-retention properties in the atmosphere, such as carbon dioxide (CO2), nitrous oxide (N2O), methane (CH4), hydrofluorocarbons (HFCs), sulfur hexafluoride

(SF6), and perfluorocarbons (PFCs).

This policy demonstrates Pireks Copper's commitment and approach to controlling and reducing emissions at

the source that may contribute to climate change.

Policy Statement

This policy covers the activities of Pireks Bakır Alaşımları as well as the activities carried out with

stakeholders within the value chain.

Responsibilities

The Board of Directors is responsible for ensuring compliance with legal obligations and for overseeing

this policy.

Management is responsible for ensuring that all employees and relevant stakeholders understand and

comply with the policy.

The Integrated Management Systems Department is primarily responsible for actively implementing

the policy, monitoring its effectiveness under the ISO 14064 management systems framework, and

ensuring that all employees are aware of, understand, and comply with it.

The Integrated Management Systems Department is also responsible for annually reporting on the ISO

14064 management system to the management.
